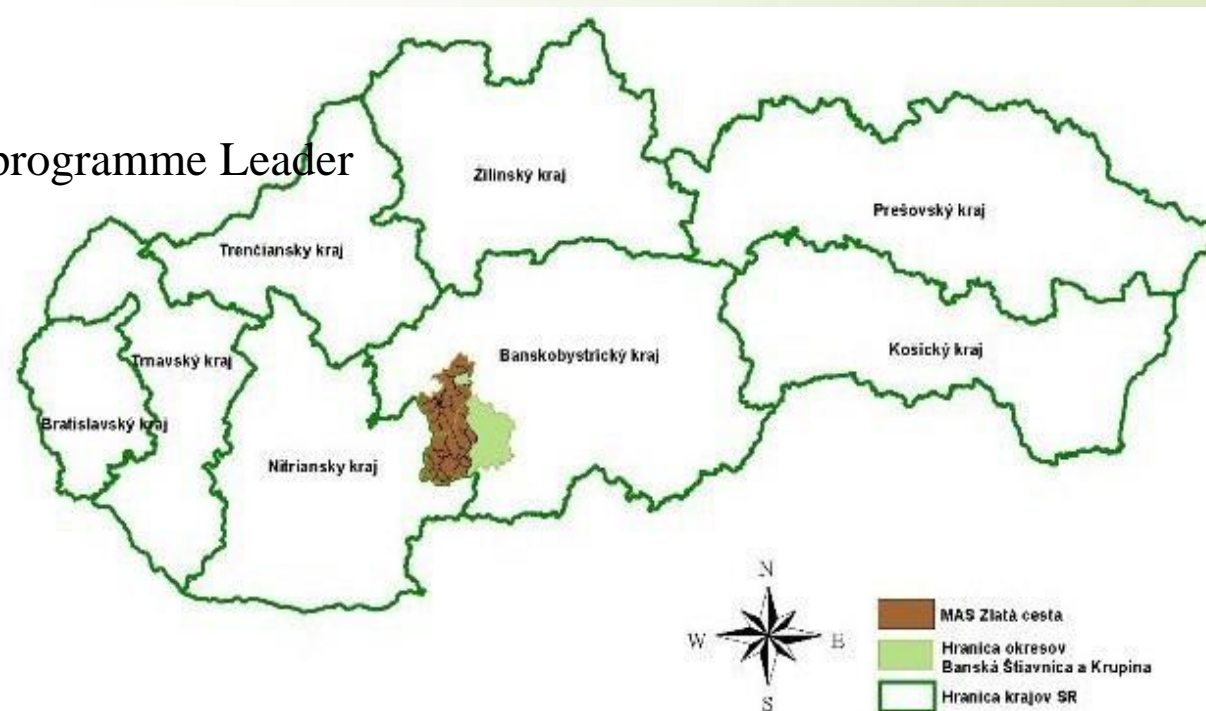
# LAG Zlatá cesta

25 thousand inhabitants , its area is 552,18 km<sup>2</sup>

The region consists of 31 villages :

- 11 villages with up to 200 inhabitants
- 10 villages with up to 500 inhabitants
- 5 villages with up to 1000 inhabitants
- 5 villages with over 1000 inhabitants

From 2003 the region prepare for the programme Leader





# Programme Leader in Slovakia

- First implementation into programmes from 2007 to 2013
  - Only measures from the line 3 – Programme of country development
  - 29 supported local action groups

# CLLD – Community-led local development

- Acronym LEADER means Liaison Entre Actions de Développement de l'Économie Rurale (connecting activities supporting economic country development). The aim of Leader is to support people of country regions to overcome new problems they face on the grounds of mutual cooperation and partnership, to think about longlasting potential of their regions and to implement mutually created integrated quality and original strategies of sustainable development.
- CLLD – Community-led local development is a new tool of development of European Union which is to be used in sub-regional levels and which completes already existing development support on the local level. CLLD can gather and involve local communities and institutions to achieve the Europe 2020 strategy in the field of intelligent, sustainable and inclusive growth, in the field of regional sustainability and achieving particular political aims.



# CLLD – Community-led local development


- ▶ Proposes of measures offer cross use of the method for particular sub-regions
- ▶ On the grounds of integrated and multi-level strategies of development
- ▶ Formed regarding local needs and potential
- ▶ Including innovations, creating nets and cooperation (SWOT analyse for multifund CLLD)
- ▶ **Recently it is named as LEADER within EAFRD**
- ▶ Local action groups



# CLLD - Multifund

- How to create it
- who to administer it
- What kind of managing body it needs
- How to approve strategies
- How to implement projects
- How to monitor them
- Programme Leader in Slovakia has a little experience
- Operational programmes communicate with each other just a little, each programme has its own tools



# Examples of „multifund“ application in Slovakia


- ▶ Local strategy of complex attitude (LSCA), the example of multifund completion of the CLLD integrated strategy in Slovakia
- ▶ A pilot project aimed at the solution of problems of Roma communities
- ▶ Coordination body is the Office of the Government Commissioner for Roma Communities
- ▶ Involved operational programmes
  - Region operational programme
  - Operational programme environment
  - OP employment and social inclusion
  - OP education, OP Healthcare
  - OP Competitiveness and Economic growth



# Local strategy of complex attitude (LSCA)

- ▶ LSCA represents project aims which focus on the solution of marginal Roma communities and within implementation of the horizontal priority „marginal Roma community“. The project aims generate synergic affect on all life aspects of Roma communities in order to improve their living conditions.





# Horizontal priorities and complex attitude

- ▶ **The aim of a horizontal priority** is to increase employment and education level of MRC and to improve their living conditions. The support of MRC focuses on four life priority fields: education, healthcare, employment and living as well as three related problem issues: poverty, discrimination and gender balance
- ▶ In order to achieve the goal of MRC the complex attitude is set which is to unite several activities or projects into the complex strategy of development in particular location in order to ensure continuation of longlasting development of marginal Roma community in the region. It focuses on mutual inter-connection of activities and active participation of the local community when implementing the project.



# Implementation of LSCA in 151 villages

- Approved support of 151 local strategies of complex attitude LSCA. On the grounds of re-assessment of the criteria to support LSCA by the inter-field evaluation and selection commission of LSCA
- In LAG Zlatá cesta there are two strategies of the villages Prenčov and Hontianske Nemce
- Allocated 200 mil €, based on 6 funds.  
Some allocations have not been exceeded, others fulfilled.
- The Government Office announced the calls to apply for completing project intentions from the agencies of agriculture, environment and the operational programmes to approved applications of LSCA



# Local strategy of complex attitude (LSCA) in Prenčov

- ▶ Terraine social help –ESF – Social development fund
- ▶ Education of children, teachers, adults, requalification – OP Education
- ▶ Creation of 10 work positions for the requalified for two years - ESF –FSR
- ▶ Opening of the community centra and the centre of hygieny –ROP
- ▶ School reconstruction –ROP
- ▶ Revitalisation of Roma settlement (pavement, road, relax zones, water) - ROP
- ▶ System of waste separation –OP Environment (two work positions )
- ▶ Three business projects (production of wood chip, advertisement studio, finishing of traditional products) (five work positions)



# Project intention


- ▶ Starting situation of the related territory for the project implementation for the priority field
- ▶ **Aims and goals of the project intention**
- ▶ Description of activities of the project intention for the related territory
- ▶ Reasoning of the project necessity in the territory
- ▶ According to the territory of the project intention, it is necessary to explain the contribution of the project to implementation of complex attitude
- ▶ **Technical data on the project**
- ▶ **financial data on the project intention**
- ▶ **Partners**



# Implementation of project intentions

- ▶ Particular operational programmes make calls, evaluate them and also implement projects
- ▶ Authorised applicants with the approved project for the relevant measure
- ▶ Application has to follow the approved project intention
- ▶ Each change has to be approved by the Office of the Government Commissioner. Otherwise the project is expelled due to inconsistency with the horizontal priority. The amount of support cannot be changed.

Monitoring of achieving LSCA – the Office of Government Commissioner – 1 per six months



# Assessing the strategy of programme frames of integrated strategies CLLD

- ▶ Selection of the principles of public bidding – assessment
- ▶ 1st level of assessment ISU (integrated strategy of the territory)
- ▶ Common inter-resort evaluation commission
- ▶ - checking the formal appropriateness yes/no  
field assessment of intentions, the ability of LAG to implement it

Guarantees of transparency and equality

- Selection – approving proposed frames
- 2nd level – particular calls for each fund – proposing programme frames
- Contracts of implementation
- And consequently announcing calls for projects of LAG
